WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on November 21, 2024 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2025 and ending December 31, 2025 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the Board of Commissioners of the Fire District will consider the Annual Budget for adoption on December 19, 2024.

2025 budget is 2,370,503.55 compared to 2024 909,619.00 increase of 1,460,884.55. The majority of the increase is for the purchase of a new Fire Truck. The purchase was approved the voters on February 17, 2024, in the amount of 1,700,000.00. 76% of the voters approved. The tax increase is 57,290.00 or a rate change from .130 to .138.

Elections up 800.00 80% due to increase costs to run a election. Professional services down 5,000.00 25% due to change in some of the professionals. Total all maintenance lines up 10,000.00 from 2024 125,000.00. Equal changes un and down for several of the items. Training and education up 3,000.00 150% for more training & education. Other operating materials down 23,400.00 23.8% funds no longer needed projects completed. Fringe benefits one line up and one down by almost the same amount. Radios up from zero to 55,000. The district need to upgrade the radios. this will be a two year process. Membership dues up 450.00 move requirements in 2025. Capital is increased to purchas a new truck with voter approvals. Fund balance increased to use funds for the new truck.
